

The Otoe County Board of Commissioners convened 8:30 a.m. on Tuesday, March 29, 2022, in the County Courtroom of the Courthouse in Nebraska City. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, Dan Crownover and James Thurman. The following motions were passed by majority vote: to approve a conservation easement application submitted by Bryan Euse for land owned by Louis Stukenholtz; to approve a \$3,000 Keno fund grant application submitted by Robert Shanks; to declare a 2088 Dodge Durango as surplus; to adopt Resolution 3-29-22-8 to authorize Jerad Sornson to sell the surplus Durango; to award a bid to Malone Construction for Project C-66(644); to award the bid to Jerad Sornson for the purchase of a surplus Grasshopper lawn mower.
