

The Otoe County Board of Commissioners convened at 8:30 a.m. on Tuesday, September 13, 2022, in the County Courtroom. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, and Dan Crownover. Commissioner James Thurman was absent. The following motions were passed by majority vote: to approve Jill Ford as member Otoe County Visitor Committee; to approve the subdivision plat of Kreifels Heights Subdivision, a 3.01+- acre tract of land located in the NE ¼ of S25, T8N, R13E as requested by Neal Niebrugge; to set the bond amounts at the minimum required by statute for County Attorney, Clerk of District Court, County Clerk, County Treasurer, and Register of Deeds; to terminate a contract with Vogtscapes and award the contract to JJK for Projects (587) and (662); adopt resolution 9-13-22-18 to increase the amount paid to local funeral homes for cost and removal of body bag and transfer of body to Douglas County for autopsy; to approve \$300,000 ARPA funding request to NCAEDC for housing incentive; to approve striking personal property tax as presented.
