

The Otoe County Board of Commissioners convened at 8:30 a.m. on Tuesday, April 25, 2023, in the County Courtroom. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, Dan Crownover, and Chuck Cole. The following motions were passed by majority vote: to cancel check #23030230; to authorize County Treasurer to transfer \$2,000 from SE Regional Emergency Management Fund 2918 to the General Fund 0100; to table the conditional use permit for Nathan Giegert/Roland Meyer; to approve a conditional use permit for a Verizon wireless facility with a 1 year provision to start building; to approve an ARPA fund request submitted by NCAEDC of \$35,000 annually between 2024 and 2026 for childcare assistance in Otoe County; to adopt Resolution #4-25-23-13 to approve setting a public hearing regarding the vacation of approximately 1200' of Otoe County Road 6, north of Otoe County Road G, located in the SW ¼ of Section 34, Township 9, Range 9; to award the bid for Project C66 (648) to Yost Excavating in the amount of \$129,771.50; to award the bid for Project C66 (682) to Ace Eaton in the amount of \$49,480 contingent on Syracuse having an interlocal agreement for the project.
