

The Otoe County Board of Commissioners convened at 8:30 a.m. on Tuesday, May 9, 2023, in the County Courtroom. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, Dan Crownover, and Chuck Cole.
