

The Otoe County Board of Commissioners convened at 8:30 a.m. on Tuesday, June 20, 2023, in the County Courtroom. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, and Dan Crownover. Commissioner Chuck Cole was absent. The following motions were passed by majority vote: to adopt Resolution #6-20-23-14; to approve the Class I liquor license application for Rich Harvest Vineyard and Winery, LLC; to approve John Chisholm to the Veteran Service Committee; to declare four sheriff vehicles as surplus; to adopt Resolution #6-20-23-15 to authorize Jerad Sornson to sell the surplus sheriff vehicles; to adopt Resolution #6-20-23-16 approving a tax refund to Badgett Hill Farms for \$234.04; to adopt Resolution #6-20-23-17 approving a tax refund to Western National Bank for \$1,683.18; to adopt Resolution #6-20-23-19 to determine that 1200' of Otoe County Road 6, north of Otoe County Road G, located in the SW ¼ of Section 34, Township 9, Range 9, 6<sup>th</sup> P.M. Otoe County, should not be vacated; to accept both bids received for hauling aggregate for July 1, 2023 – June 30, 2025; to declare a 2014 Rhino bat-wing shredder and 2003 Honda Rancher as surplus; to adopt Resolution #6-20-23-18 approving Jon Brinkman to sell said road surplus.
