

The Otoe County Board of Commissioners convened as the Board of Equalization at 8:25 a.m. on Tuesday, August 29, 2023, in the District Courtroom of the Courthouse in Nebraska City; then convened in regular session at 8:30 a.m. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, Dan Crownover, and Chuck Cole. Commissioner James Parsons was absent. The following motions were passed by majority vote: to approve the 2023 inventory statements; to approve the Eagleview Cloud Imagery proposal and set the date to finalize a contract with Eagleview and an interlocal with Nebraska City Utilities for shared costs as September 26, 2023.; to authorize the County Treasurer to open a T-bill money market account at Arbor Bank for county funds; to approve a contract with Region V for jail meal preparation; to award the bid for the jail roof replacement to Weathercraft for \$71,511.00; to adopt Resolution #8-29-23-26 to approve the tax levy allocations to political subdivisions; to adopt Resolution #8-29-23-27 to authorize the implementation and collection of fees by the Otoe County Sheriff's Office for specified services.
