

The Otoe County Board of Commissioners convened as the Board of Equalization at 8:25 a.m. on Tuesday, September 26, 2023, in the District Courtroom of the Courthouse in Nebraska City; then convened in regular session at 8:46 a.m. following the Budget Public Hearing held at 8:30 a.m. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, Dan Crownover, and Chuck Cole. The following motions were passed by majority vote: to approve board notices; to adopt Resolution #9-26-23-30 to approve the Fiscal Year 23-24 Budget; to approve a contract with EagleView for pictometry services; to approve an interlocal agreement between Otoe County and Nebraska City Utilities for shared use and expense of EagleView pictometry; to adopt Resolution #9-26-23-31 to approve setting the property tax request for FY23-24; to declare a 2009 Ford Supercrew F150 ½ ton pickup, 2012 Elite 36' gooseneck trailer, 2005 Case 580 Super M backhoe, 1993 Case Super K backhoe, and 1997 Roadmaster G440 belly dump trailer as surplus; to adopt Resolution #9-26-23-32 to approve Jon Brinkman to sell said surplus.
