

The Otoe County Board of Commissioners convened at 8:30 a.m. on Tuesday, December 19, 2023, in the District Courtroom. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, Dan Crownover, and Chuck Cole. The following motions were passed by majority vote: to adopt Resolution #12-19-23-38 to authorize the collection and to charge a fee of \$50.00 per administration of DataMaster test as allowed under Neb. Rev. Stat. 60-6,203 for certain alcohol-related offenses; to approve a Class I liquor license application submitted by Glacial Till Vineyard & Winery, LLC, dba Glacial Till Vineyard & Winery; to approve and authorize the chairman to sign the Community-Based Aid Juvenile Services Grant to the Nebraska Crime Commission; to adopt Resolution #12-19-23-39 to direct Highway Superintendent, Jon Brinkman, to conduct a vacation study on a section of road located in the West ½ of the NE ¼ of Section 3, Township 8N, Range 9E, Otoe County, NE.
