

The Otoe County Board of Commissioners convened at 8:30 a.m. on Tuesday, May 7, 2024, in the District Courtroom (208) of the Otoe County Courthouse in Nebraska City. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Commissioners Jerad Sornson, Rick Freshman, James Parsons, and Dan Crownover. Commissioner Chuck Cole was absent.
