

The Otoe County Board of Commissioners convened as the Board of Equalization at 8:25 a.m. on Tuesday, June 4, 2024, in the District Courtroom (208) of the Otoe County Courthouse in Nebraska City; then convened in regular session at 8:30 a.m. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Commissioners Jerad Sornson, Rick Freshman, James Parson, Dan Crownover, and Chuck Cole. The following motions were passed by majority vote: to approve board notices; to approve the estimate provided by Central Plains Valuation, LLC for commercial revaluations for 2025 values; to approve and sign the Acceptance of Grant Award & Special Conditions for the 2025 Community-based Juvenile Services Aid Grant; to award the bid to Travelers Insurance for \$400,513 with the option of additional cyber and deductible buydown coverage, and having a point of contact of the Sheriff; to award the bid for supplying Otoe County inventory culverts to ACE/Eaton Metals in the amount of \$117,918.00.
