

The Otoe County Board of Commissioners convened at 8:30 a.m. on Tuesday, December 17, 2024, in the District Courtroom (208) of the Otoe County Courthouse in Nebraska City. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same.
