

The Otoe County Board of Commissioners convened as the Board of Equalization at 8:25 a.m. on Tuesday, February 11, 2025, in the Otoe County District Courtroom (208) of the Courthouse in Nebraska City; then convened in regular session at 8:30 a.m. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. The members present were Commissioners Jerad Sornson, Rick Freshman, James Parsons, Dan Crownover, and Chuck Cole. The following motions were passed by majority vote: to approve the submitted motor vehicle exemption application submitted by First Baptist Church; to approve the Chairman to sign and provide a letter of commitment to contribute \$27,857.50 to Blue Rivers Area Agency on Aging for fiscal year 2025-2026; to approve an updated interlocal agreement for the Southeast Weed Management Association (SEWMA) for the addition of Cass County to the association; to approve the Collective Bargaining Agreement between Nebraska Public Employees Local 251, representing Otoe County Road/Highway Employees, and Otoe County with the change of Article 11, Section 1, Letter K, to be "after 13 years of continuous employment".
