

The Otoe County Board of Commissioners convened at 8:30 a.m. on Monday, June 16, 2025, in the County Courtroom (108) of the Otoe County Courthouse in Nebraska City. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. The members present were Commissioners Jerad Sornson, Rick Freshman, James Parsons, Dan Crownover, Chuck Cole. The following motions were passed by majority vote: to approve and sign the Acceptance of Grant Award & Special Conditions for the 2025-2026 Community-based Juvenile Services Aid Grant; to approve an agreement with Cedars to continue supporting the Diversion Program; to approve a contract between Otoe County and Thomson Surveying LLC for County Zoning Administrator services; to adopt resolution #6-16-25-9 authorizing the transfer of funds to meet budgetary requirements for the County Board, Coroner, Child Support, Agricultural Extension Service, County Attorney, Probation Office, Welfare Assistance Administration Office budgets; to award the bid for Project C-66(679) Dunbar Northwest to Herbst Constructions for \$954,984.00.
