There being no other nominations, Cole made a motion, seconded by Freshman to close nominations and appoint Commissioner Jerad Sornson as Chairman of the Board for year 2025. Voting aye were Commissioners Parsons, Crownover, Cole, Sornson and Freshman. Nay – none. Motion carried.

The Clerk called for nominations from the floor for election of a Vice-Chairman of the Board for year 2025. Commissioner Sornson nominated Commissioner Rick Freshman as Vice-Chairman of the Board. There being no other nominations, Cole made a motion, seconded by Crownover to close nominations and appoint Commissioner Rick Freshman to be Vice-Chairman of the Board for year 2025. Voting aye were Commissioners Crownover, Cole, Sornson, Freshman and Parsons. Nay – none. Motion carried.

The meeting was returned to the Chairman of the Board.

<u>REGION V / APACE</u>: Commissioner Crownover will serve as the Otoe County representative and Commissioner Parsons will serve as the alternate.

BRAAA (Blue Rivers Area Agency on Aging): Commissioner Crownover will serve as the Otoe County representative and Commissioner Freshman will serve as the alternate.

<u>Southeast District Health</u>: Commissioner Parsons will serve as the Otoe County representative and Commissioner Cole will serve as the alternate.

Road & Bridge Committee: Commissioner Freshman and Commissioner Sornson will serve as representatives.

Parsons made a motion, seconded by Freshman, to appoint the following financial institutions as depositories for Otoe County in 2025: Commercial State Bank, Nebraska City, First Nebraska Bank, Nebraska City, Farmers and Merchants Bank, Palmyra, NPAIT (Nebraska Public Agency Investment Trust), Riverstone Bank, Arbor Bank & Trust, Nebraska City, Countryside Bank, Unadilla, First Bank of Nebraska, Syracuse, Premier Bank, Nebraska City, and Union Bank & Trust as financial depositories for 2025. Voting aye were Freshman, Parsons, Crownover, Cole, and Sornson. Nay – none. Motion carried.

Freshman made a motion, seconded by Cole, to audit and sign payroll claims. Voting aye were Crownover, Cole, Sornson, Freshman, and Parsons. Nay – none. Motion carried.

Chairman Sornson acknowledged receipt of the monthly report from the Clerk of the District Court certifying fee collections in the amount of \$23,936.60 for the month of December 2024. Said report will be filed in the County Clerk's Office.

Chairman Sornson acknowledged receipt of the quarterly report from the County Sheriff denoting the amount of certain fees collected, from whom and for what service. The total amount received in the fourth quarter of the year was \$11,970.49

Chairman Sornson acknowledged receipt of the financial reports for quarter ending December 31, 2024, of the petty cash accounts held by Jenny Bassinger, County Clerk; Gregg Goebel, Emergency Management; Ruth Ann Weddle, Register of Deeds; Colin Caudill, Sheriff; Jenniffer Panko-Rahe, County Attorney; Janis Riege, Clerk of the District Court and Dana Ritchheart, County Court Magistrate. Said reports will be kept on file in the County Clerk's Office.

Sornson opened a public hearing to hear comments regarding a Class C liquor license application submitted by Fox Creek Landing, LLC. Kevin Knorr, owner, stated that the building was originally built to house a drone business and with a potential event/wedding venue in mind. The liquor license would be for events and/or

weddings. There were no other public comments, and Sornson closed the public hearing. Parsons made a motion, seconded by Cole, to approve a Class C liquor license application submitted by Fox Creek Landing, LLC. Voting aye were Cole, Sornson, Freshman, Parsons, and Crownover. Nay – none. Motion carried.

A KENO application was submitted by Lewis and Clark Visitor Center in the amount of \$10,000.00. Doug Friedli, representing Lewis and Clark Visitor Center explained that the organization is building a fort area at the Center. Five cabins have been built, and they are requesting funds to complete the surrounding wall of the fort. The funds would be used to gather and transport logs and the construction of the wall. He stated that the project could increase the number of visitors to the Center and that would benefit the City of Nebraska City and Otoe County with the visitors staying and/or shopping in the area. Cole made a motion, seconded by Crownover, to approve the KENO fund application submitted by the Lewis and Clark Visitor Center in the amount of \$10,000.00. Voting aye were Sornson, Freshman, Parsons, Crownover, and Cole. Nay – none. Motion carried.

The Collective Bargaining Agreement between Nebraska Public Employees Local 251 representing Otoe County Road/Highway Employees and Otoe county was tabled until the January 28, 2025 meeting.

Parsons made a motion, seconded by Cole, to adopt Resolution #1-14-25-1 authorizing the increase of fees collected by Otoe County for driveway permits, issuance of 911 addresses, and right of way permits. The fees will double the previous amounts making the new fee schedule to be: Occupy County Right of Way with Driveway \$50.00; 911 Address Sign \$50.00; and Construct Utilities on County Right of Way per plow or bore \$100.00. Voting aye were Freshman, Parsons, Crownover, Cole, and Sornson. Nay – none. Motion carried.

Brian Briley, Roads Lead Supervisor, presented a road report.

There being no further business to come before the Board at this time, and since all items on the agenda have been disposed of Chairman Sornson declared this meeting adjourned at 9:00 a.m. The next regular meeting will be held on January 28, 2025.
