Freshman made a motion, seconded by Cole, to audit and sign payroll claims. Voting aye were Crownover, Cole, Sornson, and Freshman. Nay – none. Motion carried.

Michelle Boutin requested an exception to the planning regulation that requires a three-acre parcel for building a new residence. Mr. and Mrs. Boutin purchased a one-acre parcel; Parcel #004219500. Dave Schmitz, Planning and Zoning Administrator, stated that the parcel was once an old school site in the 1890's and is a corner parcel. He stated that there have been exceptions before for old school sites and with the historical background, the request was not required to go before the planning and zoning board and he as the planning and zoning admin could approve for them. He said that if the septic and well requirements could be met on the one-acre tract, he did not have an issue. The Boutins stated those measurements were completed and all setbacks could be met, but they have not had the water tested. Sornson made a motion, seconded by Cole, to approve an exception to the three-acre minimum zoning regulation for building to Michelle Boutin for parcel #004219500 contingent on a completed and approved water test. Voting aye were Sornson, Freshman, Crownover, and Cole. Nay – none. Motion carried.

Tom Farrell, Miller Farrell Ins. was not able to attend, and his presentation was tabled until the March 11, 2025, meeting.

Sornson opened a public hearing to hear comments regarding the subdivision plat of Ruge's Cozy Acres Subdivision, a 5.26+- acre tract located in the S ½ of the SE ¼ of Section 17, Township 9N, Range 11E as proposed by Ward Ruge, Jenny Ruge, and Pamela Lefferdink. The site is located at 2745 D Road. David Schmitz, Otoe County Surveyor and Planning/Zoning Administrator, stated that as of today's meeting, the 2024 taxes had not been paid and that the plat could not be filed until paid. There was no public comment, and the public hearing was closed. Crownover made a motion, seconded by Cole, to approve the subdivision plat of Ruge's Cozy Acres Subdivision, a 5.26+- acre tract located in the S ½ of the SE ¼ of Section 17, Township 9N, Range 11E contingent on the approval for rural water hook-up and the 2024 taxes being paid. Voting aye were Freshman, Crownover, Cole, and Sornson. Nay – none. Motion carried.

Sornson opened a public hearing to hear comments regarding the subdivision plat of J & D Reese Subdivision, a 3.00+- acre tract of land located in the N ½ of the NW ¼ of Section 16, Township 8N, Range 13E, as proposed by Janis J. Gress. The site is located at 5246 I Rd. Dave Schmitz, Otoe County Surveyor and Planning/Zoning Administrator stated that the presented plat is a corrected version of the original plat proposed. The acre/description did not change but the layout did. There was no public comment, and the public hearing was closed. Cole made a motion, seconded by Freshman, to approve subdivision plat of J & D Reese Subdivision, a 3.00+- acre tract of land located in the N ½ of the NW ¼ of Section 16, Township 8N, Range 13E. Voting aye were Crownover, Cole, Sornson, and Freshman. Nay- none. Motion carried.

Sornson opened a public hearing to hear comments regarding a conditional use permit for a commercial building where the building stalls may be leased or sold, located in Lots 10 & 11, M & M Commercial Park Subdivision located in the N ½ of the NW ¼ of Section 33, Township 9N, Range 9E as proposed by BLV Falcon, LLC per Seth Vontz. David Schmitz, Otoe County Surveyor and Planning/Zoning Administrator, stated

that the planning and zoning board approved for building and leasing. It was discussed and confirmed that the stalls would not be used for residential living space. There was no public comment, and the public hearing was closed. Freshman made a motion, seconded by Cole, to approve a commercial building where the building stalls may be leased, located in Lots 10 & 11, M & M Commercial Park Subdivision located in the N ½ of the NW ¼ of Section 33, Township 9N, Range 9E as proposed by BLV Falcon, LLC per Seth Vontz. Voting aye were Cole, Sornson, Freshman, and Crownover. Nay – none. Motion carried.

Cole made a motion seconded by Crownover to approve the transfer of a surplus Emergency Management grant funded trailer to the Otoe County Amateur Radio Association. Gregg Goebel, Otoe County EMA Director, explained that the acquisition of another trailer has caused this trailer to be surplus equipment. By transferring the trailer to the Otoe County Amateur Radio Association, the organization will be able to set it up for HAM radio use in emergencies. The organization would take over any and all future costs after receiving the trailer. Cole made a motion, seconded by Crownover, to approve the transfer of a surplus Emergency Management grant funded trailer to the Otoe County Amateur Radio Association. Voting aye were Sornson, Freshman, Crownover, and Cole. Nay – none. Motion carried.

Two quotes for the 2025 annual bridge inspections were received. Both quotes were for 140 routine and 12 fracture critical (NSTM) inspections. Mainelli Wagner & Associates \$24,785.00, and Midwest Engineering, Inc. \$23,980.00. Freshman made a motion, seconded by Cole, to approve a contract with Midwest Engineering, Inc. for completing the 2025 bridge inspections in the amount of \$23,980.00. Voting aye were Freshman, Crownover, Cole, and Sornson. Nay – none. Motion carried.

Brian Briley, Roads Lead Supervisor, presented a road report.

There was no public comment.

Cole made a motion, seconded by Freshman, to go into executive session. Chairman Sornson stated the closed session would be to discuss the vacation accruals for the road department. Voting aye were Crownover, Cole, Sornson, and Freshman. Nay – none. Motion carried. Executive session was entered at 9:14 a.m. Cole made a motion, seconded by Freshman, to reconvene in regular session. Voting aye were Cole, Sornson, Freshman, and Crownover. Nay- none. Motion carried. Regular session was reconvened at 9:38 a.m.

There being no further business to come before the Board at this time, and since all items on the agenda have been disposed of Chairman Sornson declared this meeting adjourned at 9:38 a.m. The next regular meeting will be held on March 11, 2025.
