Cole made a motion, seconded by Freshman, to audit and sign payroll claims. Voting aye were Crownover, Cole, Sornson, Freshman, and Parsons. Nay – none. Motion carried.

Lisa Walker, NCAEDC Director, and Jason Esser, NCAEDC Board of Directors Chairman, requested a \$10,000 increase in the county's annual contribution to NCAEDC. The county has contributed \$40,000 annually for approximately the past 15 years and the request is to increase the annual contribution to \$50,000. Mr. Esser explained other funding sources for the local organization and presented budget figures for similar organizations in counties comparable to Otoe County's size. After discussion, no action was taken. The funding request will be proposed during the figuring of the county's budget for the next fiscal year. No action was taken.

Vanessa Sherman, Juvenile Diversion Coordinator, presented the 2025-2026 Community-based Juvenile Services Aid Grant. The grant award amount is \$50,004.00. She explained that the document presented is the acceptance of the grant award and special conditions of the grant. Freshman made a motion, seconded by Cole, to approve and sign the Acceptance of Grant Award & Special Conditions for the 2025-2026 Community-based Juvenile Services Aid Grant. Voting aye were Sornson, Freshman, Parsons, Crownover, and Cole. Nay – none. Motion carried.

There were two items on the agenda regarding contracts with Cedars. It was determined that they were the same and were combined into one discussion/action. Ms. Sherman explained to the board that Cedars provides services to the Diversion Program at an increased level. The hourly price remains the same as the previous contract at \$92/hour. The agreement is for the July 1, 2025 – June 20, 2026, or when grant funds are no longer available, whichever is sooner. Cole made a motion, seconded by Crownover, to approve an agreement with Cedars to continue supporting the Diversion Program. Voting aye were Sornson, Freshman, Parsons, Crownover, and Cole. Nay – none. Motion carried.

Ms. Sherman, and Jenniffer Panko-Rahe, Otoe County Attorney, spoke to the board regarding the restructuring of the Diversion Program. Currently, Ms. Sherman is the Juvenile Diversion Director and Central Navigator. The P4OC organization had provided \$13,200 annually for Ms. Sherman's work with the Central Navigation and employed two part-time coaches for the program. P4OC is requesting some changes and Ms. Sherman and Mrs. Panko-Rahe discussed some options with the board. One option would involve Ms. Sherman decreasing her participation with the Central Navigation and the county needing to fund the portion of her pay that was provided by P4OC, another option would involve the county employing the part-time coaches. There may be expenses that include cell phones and computers that have been funded through P4OC. Additional information and potential costs of options were requested. No action was taken.

There was discussion of Planning/Zoning Administrator position and the reason it was an appointed position and not an employed position. The position has been appointed for 20+ years, and the discussion was to leave it as such. Dan Thomson, Otoe County Surveyor, was appointed as the Planning/Zoning Administrator upon the retirement of David Schmitz. Mr. Thomson presented a contract to the board between Otoe County and Thomson Surveying LLC for planning/zoning services. The contract provides for Mr. Thomson's liability insurance for the planning/zoning services to be reimbursable. Cole made a motion, seconded by Parsons, to approve a contract between Otoe County and Thomson Surveying LLC for County Zoning Administrator services. Voting aye were Parsons, Crownover, Cole, Sornson, and Freshman. Nay – none. Motion carried.

Chad Miller, Otoe County Veteran Service Officer, spoke to the board regarding the potential of an interlocal agreement with Nemaha County for Veteran Services. He stated that he is currently averaging eight hours a week developing claims for Nemaha County veterans and making approximately 80% of their disability claims. Nemaha County's current budget is \$30,000 for the service. Mr. Miller stated that other counties of similar size that work together with interlocal agreements for this service are approximately \$30,000/year plus 25% operational costs. No action was taken.

It was reported that seven budgets would require a fund transfer to meet the financial obligations of FY 24-25. Cole made a motion, seconded by Parsons, to adopt resolution #6-16-25-9 authorizing the transfer of funds to meet budgetary requirements for the County Board, Coroner, Child Support, Agricultural Extension Service, County Attorney, Probation Office, Welfare Assistance Administration Office budgets. The resolution authorizes the transfer of \$32.00 for County Board, \$3,950.00 for Coroner, \$2,628.28 for Child Support, \$7,029.87 for Agricultural Extension Services, \$528.25 for County Attorney, \$803.58 for Probation Office, and \$2,167.92 for the Welfare Assistance Administration Office. All budgets are within the general fund and funds will be transferred from the General miscellaneous budget. Voting aye were Parsons, Crownover, Cole, Sornson, and Freshman, Nay – none. Motion carried.

Bids for Project C-66 (679) Dunbar Northwest were publicly opened on Friday, June 13, 2025, at 9:00 a.m. The project is the construction of a 3-span 110'-0" continuous concrete slab bridge, culvert installation, and other related incidental work. County Commissioners Jerad Sornson and Rick Freshman, Deputy County Clerk Mary Bennett, and Adam Mace, representing Mainelli Wagner Engineering, were present to represent the county. There were representatives from some of the construction companies present at the bid opening as well. Bids received for Project C-66(214):

This project is an approved CBMP project and will be reimbursed 55% to the county. Voting aye were Crownover, Cole, Sornson, Freshman, and Parsons. Nay – none. Motion carried.

Brian Briley, Road Lead Supervisor, presented the road report.

There was no public comment.

There being no further business to come before the Board at this time, and since all items on the agenda have been disposed of Chairman Sornson declared this meeting adjourned at 9:37 a.m. The next regular meeting will be held on July 1, 2025.
