There being no further discussion, Chairman Sornson called for a vote. Voting aye were Commissioners Freshman, Crownover, Cole, and Sornson. Nay – none. Motion carried.

Cole made a motion, seconded by Freshman, to audit and sign payroll claims. Voting aye were Cole, Sornson, Freshman, and Cole. Nay – none. Motion carried.

John Mabry and Amanda Fahrer of Lincon Food Bank presented information on the services provided by the food bank.

Freshman made a motion, seconded by Crownover, to approve the 2025 inventory statements. Voting aye were Sornson, Freshman, Crownover, and Cole. Nay – none. Motion carried.

Chairman Sornson acknowledged the receipt of an itemized report from the Otoe County Treasurer of the amount of personal property taxes that remain uncollected after distress warrants were issued in November 2024. The total unpaid amount is \$5,509.95.

Cole made a motion, seconded by Crownover, to adopt Resolution #8-26-25-13 to approve tax levy allocations to political subdivisions. These allocations are for the political subdivisions that the county is required to allocate a levy: hospital, ag society, rural fire districts. Voting aye were Freshman, Crownover, Cole, and Sornson. Motion carried.

Freshman made a motion, seconded by Crownover, to adopt Resolution #8-26-25-15 to authorize creating the Reappraisal Fund (1100) for the County Budget effective FY25-26. There are currently funds set aside for commercial appraisals in the 950 Sinking Fund, which is an equipment sinking fund and the appraisal funds should be in a fund such as the Reappraisal Fund. The funds currently in the 950 Sinking Fund for the Assessor will be transferred to the 1100 Reappraisal Fund. Voting aye were Crownover, Cole, Sornson, and Freshman. Nay – none. Motion carried.

Crownover made a motion, seconded by Cole, to adopt Resolution #8-26-25-14 to authorize creating the County Sinking Fund (2750) for the County Budget effective FY25-26. Voting aye were Cole, Sornson, Freshman, and Crownover. Motion carried.

Al Haug, Haug Communications Inc., spoke to the board regarding the tower being donated for the statewide radio project and the land lease agreement with Leonard and Melvin Kreifels. The land lease agreement is currently between Haug Communications, Inc., Leonard Kreifels, and Melvin Kreifels. Haug Communications, Inc. is planning to donate the tower to Otoe County, but the land the tower is on is leased. Mr. Haug stated that the current lease is for twenty years and has approximately 11 years left. The lease agreement is transferable. There was no action taken on the lease agreement as the board asked the County Attorney to review the agreement. The approval of transferring the lease to Otoe County will be placed on the September 9, 2025, agenda. The next annual payment is due on Sept. 1, 2025. Mr. Haug, or a commissioner, will communicate with Leonard and Melvin Kreifels regarding the pending approval of the transfer of the lease.

Freshman made a motion, seconded by Crownover, to approve opting in to the new National Opioids Secondary Manufacturers Settlements and authorizing the Chairman to electronically sign. Voting aye were Sornson, Freshman, Crownover, and Cole. Nay – none. Motion carried.

There was a review of the FY25-26 Budget. The levy will decrease slightly, and the county will be required to participate in the Joint Public Hearing.

Cole made a motion, seconded by Crownover, to adopt Resolution #8-26-25-16 to authorize the Chairman to sign the Annual Certification of Program Compliance to Nebraska Board of Public Roads Classifications and Standards 2025. Voting aye were Freshman, Crownover, Cole, and Sornson. Nay – none. Motion carried.

Brian Briley, Road Lead Supervisor, presented the road report.

During the public comment section, Tom Grooman provided his opinion of Otoe County having the best Veteran Service Officer in the State of Nebraska and recommended the increase of his to whatever amount the Veteran Service Officer requested.

Cole made a motion, seconded by Freshman, to enter closed executive session. Chairman Sornson stated that the reason for the closed session was to discuss the Veteran Service Officer's salary increase. He informed the public that no action would take place during closed session, and that following the closed session, the meeting would be adjourned. Voting aye were Crownover, Cole, Sornson, and Freshman. Nay – none. Motion carried. Closed session entered at 9:11 a.m. Cole made a motion, seconded by Crownover, to reconvene in regular session. Voting aye were Cole, Sornson, Freshman, and Crownover. Nay – none. Motion carried. Regular session re-entered at 9:51 a.m.

There being no further business to come before the Board at this time, and since all items on the agenda have been disposed of Chairman Sornson declared this meeting adjourned at 9:52 a.m. The next regular meeting will be held on September 9, 2025.
