A complete copy of the filed Form 422s and determinations will be kept on file in the Otoe County Clerk's office.

There being no further business to come before the Board of Equalization at this time and since all the items on the agenda have been disposed of Chairman Sornson declared the meeting adjourned at 8:27 a.m.
